AGREEMENT, WAIVER AND PAYMENT (1 of 2):

Participant (adult and minor), joined by Parent if the participant is a minor, in consideration of the services of Calleva Inc., acknowledges and agrees as follows:

ACTIVITIES AND RISKS: I understand that Calleva has attempted to provide its participants with appropriate equipment and skilled staff for its programs (course, seminar, or trip). Nevertheless, the activities of the programs have risks, including certain risks which are inherent. Inherent risks are those which cannot be eliminated without destroying the unique character of the activities. The same elements that contribute to the unique character of these activities can cause loss or damage to the equipment, accidental injury, illness, or, in extreme cases, permanent trauma, disability or death. Calleva does not want to frighten its participants or reduce their enthusiasm, but considers it important for them and their families to know in advance what to expect, and to be informed of the activities' inherent risks. The following describes some, but not all, of those risks.

- Calleva programs live, camp and travel out of doors, where they are subject to numerous environmental and other risks. Activities vary from program to program and may be strenuous, physically and emotionally. The activities include hiking and backpacking, mountain boarding, climbing and descending rock cliffs, kayaking, rafting, canoeing, sailing, horseback riding, skiing, snowboarding, mountain biking, fishing, and caving.
- Equipment may fail or malfunction, despite reasonable maintenance and use.
- Meals are prepared over gas stoves and open fires. Camping risks and hazards include burns, cuts, slips, falls, lifting, and diarrhea and flu-like illness.
- Decisions are made by the instructors and participants usually are in a wilderness setting, based on a variety of perceptions and evaluations which by their nature are imprecise and subject to errors in judgment. Misjudgments may pertain to, among other things, a participant's capabilities, environment, terrain, water and weather conditions, natural hazards, routes and medical conditions.
- Calleva activities are instructional in nature and students will be challenged to expand their skills and judgment.

I have read and understand the general information about Calleva and its courses in the Calleva literature and/or at the Calleva website. The staff of Calleva (by phone or email) has been available to more fully explain the nature and physical demands of the activities in which I will be engaged, and the inherent and other risks of my Calleva activity.

ACKNOWLEDGEMENT AND ASSUMPTION OF INHERENT AND OTHER RISKS: I understand and acknowledge that the description above ("Activities and Risks") of the inherent risks of Calleva's activities is not complete and that other, including unknown or unanticipated, risks, inherent and otherwise, may result in property loss, injury, illness or death. I acknowledge that my participation in this Calleva program is purely voluntary, and I wish to participate in spite of and with knowledge of the inherent and other risks involved. I acknowledge and assume the inherent risks described above and all other inherent risks of my Calleva activity. In addition, except for an injury or other loss which occurs on lands whose rules or regulations prohibit my doing so as a matter of law, I expressly assume ALL risks of my Calleva activity, inherent or otherwise, and whether or not described above.

AGREEMENT OF RELEASE AND INDEMNITY: If I am an adult Participant or the Parent of a minor Student I agree, for myself and on behalf of the minor student for whom I sign, as follows:

On behalf of myself and any minor child for whom I sign. I hereby release and hold harmless Calleva, its owners, directors, officers, employees, contractors and other agents (each a "Released Party") from all liabilities, injuries, damage, causes of action, complaints, suits, claims, obligations, costs, losses and all other legal responsibilities (collectively, "Claims") suffered by me or such minor child and arising from participation in any activity of Calleva unless such Claim is caused by the gross negligence, malice or willful misconduct of the Released Party against whom the Claim is brought. I specifically agree not to institute or cooperate with any Claim in violation of the foregoing sentence. I further agree to indemnify and defend Calleva or any other Released Party against any Claim that may be brought against it by any person if such Claim is attributable to any of my or my minor child's actions or failure to act, if such actions or failure to act constituted gross negligence, malice or willful misconduct on the party of my child or me.

OTHER PROVISIONS: *Calleva is authorized to obtain or provide emergency hospitalization, surgical or other medical care for me, or for the minor Participant. Any such third-party medical care provider is authorized to exchange pertinent medical information with Calleva. Costs reasonably associated with medical services, including evacuation, shall be borne by me.*

Calleva may share my or the minor Participant's contact information with other Calleva participant or graduates and/or with environmental organizations or strategic partners in which Calleva graduates may be interested. Calleva may also use my or the minor Participant's name, contact information and picture in promotional materials and press releases.

AGREEMENT, WAIVER AND PAYMENT (2 of 2):

GENERAL EXPECTATIONS AND STANDARDS: In all Calleva programs, trust, communication, honesty and integrity are keys to a successful community. Although some expectations and standards will be decided within the group, there are others that are simply not negotiable that relate to safety, the law and other obvious reasons. Such expectations and standards relate, for instance, to the use of life jackets, swimming (no swimming alone or after dark), the proper use of equipment, fire safety and special exclusive relationships (not allowed), etc. For health, safety, privacy or other reasons, repeated failure to adhere to such standards may lead to dismissal from a program.

The following are absolutely **not permitted** by participants in Calleva programs:

- the use and/or possession of illegal drugs and/or alcohol
- the use of any tobacco products
- Breaking one of these major expectations leads to dismissal.

HEALTH: We understand that Calleva requires participants to have a current Health Form completed on-line.

PHOTO RELEASE: We hereby allow Calleva to use photographs or images of me/my child for appropriate promotional material related to the activity the participant will be enrolled in.

ELECTRONICS: Calleva is not responsible for loss and/or damage to any electronic device. Calleva does not allow the use of ipods, mp3 players, etc. In terms of phones and other electronic devices, assume everything will get wet.

PAYMENT INFORMATION: TUITION: Please enclose the deposit of \$150/week to be credited to your tuition and fill out our on-line Health Form. No space in any Calleva program will be held completed health form. The deposit is non refundable.

WITHDRAWALS/DISMISSALS: The family is responsible for the entire tuition if participant withdraws after April 30th. If the participant leaves during camp by mutual agreement with the Director (health, etc.), the tuition will be pro-rated minus deposit. Refunds (minus deposits) are available before April 30th.
